TERMINATION OF MEMBERSHIP

- a. A member may resign from membership of the VTG, and upon acceptance of his resignation by the Executive Committee, he shall cease to be a member.
- b. The annual subscription of a member shall become due on 1st April of each year. If the subscription is not paid within 60 days from the 1st April of each year, the member will be deemed to be a defaulter. If any member fails to pay his subscription beyond the period of 60 days from 1st April of each year, the Secretary shall issue a notice calling for payment through certified post of such dues within 30 days and if payment is not made within the said 30 days from the date of receipts of the notice, the member shall cease to be a member of the Guild.
- c. A member who causes damage or prejudice to the Guild or who does not comply with the rules and regulations of the Guild may be expelled from membership of the Guild by a resolution of the Executive Committee, passed at a duly convened meeting and supported by at least ¾ of the members present. The voting on the resolution shall be by Secret Ballot. The President shall have a casting vote.
